MEETING REPORT – DECEMBER 7, 2021

The Cedar Landing 2 – Creek Estates Road Maintenance Organization (RMO) Board of Directors convened at 507 Bishop Drive on Tuesday, December 7, 2021 at 6:30 pm.

President Steven Hanchey convened the meeting.

The report of the November 2, 2021 meetings was accepted.

- I. Member Issues None
- II. Road Maintenance
 - A. BLI Work

Members noted that several positive comments had been made by community residents following BLI's recent activity, adding crushed concrete to most of Creek Drive, stabilizing the Creek Drive intersections at Bishop and Donna's Drive and at Cedar Court, and cutting back the overgrown foliage in drainage ditches along Cedar Avenue. Additional work to be done in December includes asphalt repair on Cedar Avenue. Outstanding projects for 2022 include:

- Cedar Avenue Remove first speed bump and install new bump farther down the road to allow vehicles to clear the intersection before slowing for bump (Tabled)
- Pine Ridge Court at Cedar Avenue Fill hole at northwest corner of intersection (Need estimate)
- Bishop Court Determine cost and consider adding crushed concrete to raise the entire roadbed (~\$9,000)
- Bishop Drive Determine cost and consider adding crushed concrete to raise the entire roadbed (\$6,500)
- Bishop Drive at Cedar Avenue fill hole in southeast corner of intersection (~\$1,000)
- 607-609 Park Drive deepen ditch to prevent backflow of water (No cost)

B. Other Road Work

Members noted that the security light at the intersection of Landing and Driftwood Drives has been installed, that the trees along #210 before Cedar Avenue have been trimmed, and that the replacement sign for Landing Drive has been ordered.

Members approved the following language for Landing Court signage:

Private boat launch Cedar Landing 2 – Creek Estates owners only Temporary vehicle and trailer parking Cedar Landing 2 – Creek Estates owners only

Members agreed that a letter to all Landing Court owners reminding them of the use and easement would be mailed before the signage is installed.

Members reviewed and approved the revised speed bump policy that notes the necessity for Pender County Fire Marshal and RMO approval and requires installation by the RMO contractor.

II. Financial Operations

Treasurer Ann Donnelly reported a current bank balance of \$5,913.00with 79% of those who routinely pay their fees having paid for 2021.

Members reviewed and approved the report of RMO activity and funds received and spent, noting that this will be finalized when BLI's invoice for December work has been received and will be sent with the 2022 fee statements.

Members noted several pending issues:
